Creating Shared National Water Data Management Systems towards a Mediterranean Water Knowledge Hub

Technical workshop on integrated water resources management (IWRM) indicators

30th September - 1st October 2013, Barcelona

Venue: Union for the Mediterranean's General Secretariat in Barcelona, Banqueting Room/Billiard Room

Duration: A day and a half workshop

Language: Simultaneous translation will be provided in French and English

Background

This workshop is organized in the framework of the UfM regional project “*Creating Shared National Water Data Management Systems towards a Mediterranean Water Knowledge Hub*”.

Two partners of this project, Plan Bleu (regional activity centre of UNEP-MAP) and EMWIS are implementing one preliminary activity of this project in 2013 in parallel to the preparation to the UfM label. The objective is to make an assessment of indicators used for Integrated water resources management in the four pilot countries of this project (Jordan, Lebanon, Morocco and Tunisia) as well as in the framework of international initiative acting the Mediterranean area. This action also aims to facilitate monitoring of Mediterranean Strategy for Sustainable Development (MSSD) and its outputs will feed the MSSD revision process planned in 2014 and 2015.

Plan Bleu, EMWIS and the UfM Secretariat are mobilizing their own financial resources for this action as well as a support from the French National Agency for Water and Aquatic Environments (Onema).

Plan Bleu is a Regional activity centre attached to the Mediterranean Action Plan (MAP/UNEP) which has a twofold mandate: (i) producing information and knowledge in order to alert decision makers and stakeholders to the environmental challenges in the Mediterranean and (ii) drawing up scenarios for the future to assist in the decision making process. Plan Bleu will bring to the project its expertise in terms of indicators and regional water information systems. (<http://planbleu.org/>)

EMWIS is an initiative of the Euro-Mediterranean Partnership, providing a strategic tool for exchanging information and knowledge in the water sector between and within the Euro Mediterranean partnership countries (16 Mediterranean Partner Countries + EU). (<http://www.semide.net/>)

The UfM is an intergovernmental organization involving 43 countries of the Mediterranean region and of the European Union; it has been given a ministerial mandate to develop shared Information Systems on water for the Mediterranean (<http://ufmsecretariat.org/>).

Objectives of the meeting

This technical workshop has three objectives:

1. To present a **review of the existing situation and needs in terms of IWRM indicators**, and specifically in 4 pilot countries (Jordan, Lebanon, Morocco, Tunisia) involved in this project;
2. To **agree on the most suitable priority IWRM indicators** that could be applied at the national level with possible aggregation at international level;
3. To **identify the related requirements for the National water information system** in terms of data management.

Some preliminary work has already been carried out by Plan Bleu on IWRM indicators and synthetized in a draft report which will serve as a basis for discussion during the workshop. After the workshop, technical visits will be organized in each pilot country and a final report with recommendations for the project will be produced at the end of 2013.

Participants

About twenty individuals will be invited to participate in the meeting. The workshop will gather several representatives from the pilot countries and the catchment areas responsible for IWRM, and representatives from the main international organisations producing indicators in the Mediterranean region (Arab League, CEDARE/AMCOW (MEWINA project), EEA, FAO (Aquastat), MedPol, Tour du Valat, UNEP-MAP, UN-Water).
