What is the Union for the Mediterranean?

The Union for the Mediterranean (UfM) is a unique intergovernmental Euro-Mediterranean organisation which brings together all 28 countries of the European Union and 15 countries of the Southern and Eastern Mediterranean. The UfM provides a forum to enhance regional cooperation, dialogue and the implementation of concrete projects and initiatives with tangible impact on our citizens, with an emphasis on young people, in order to address the three strategic objectives of the region: stability, human development and integration.

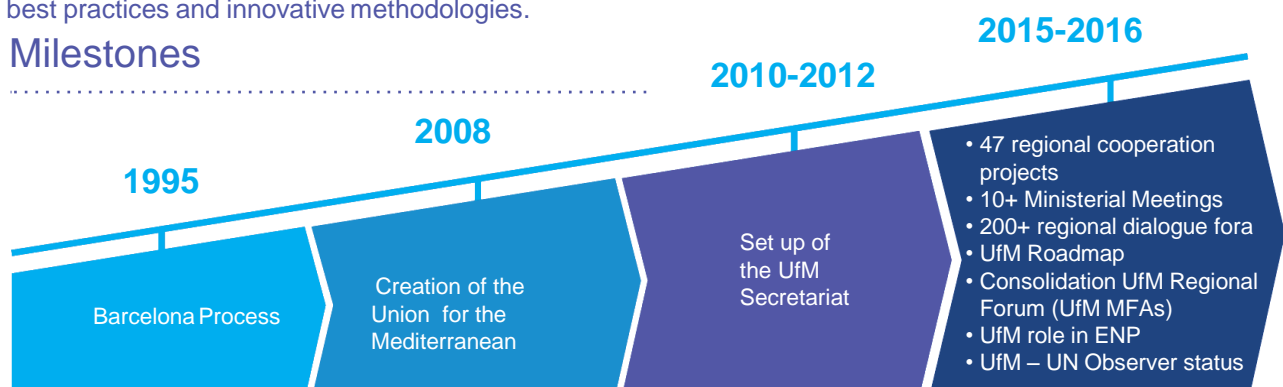


1 Secretariat

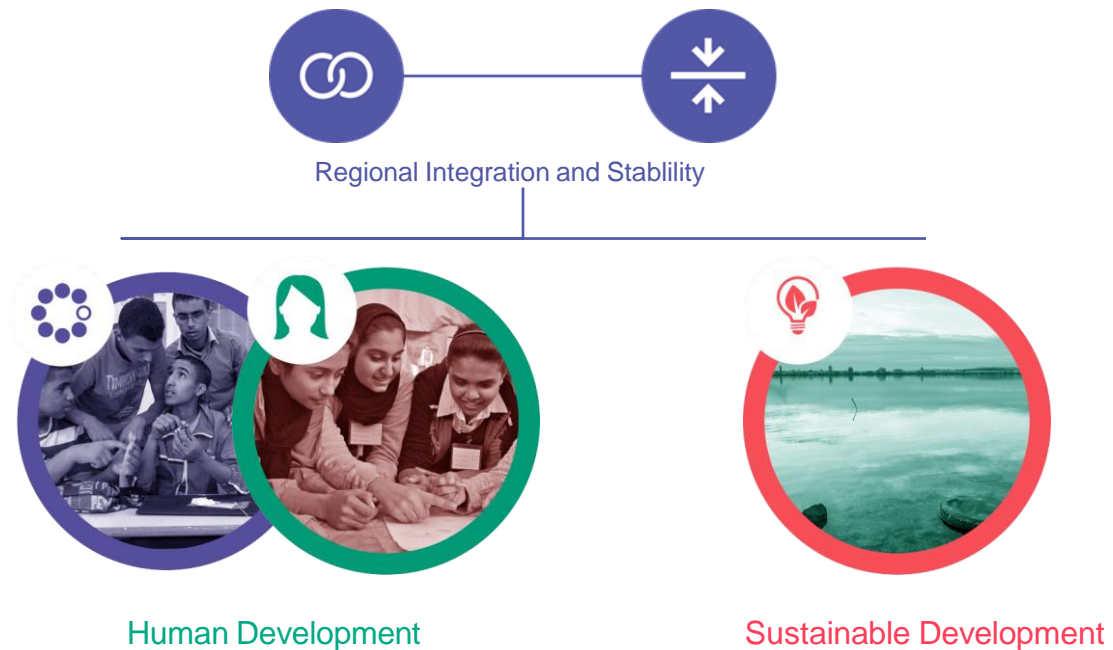




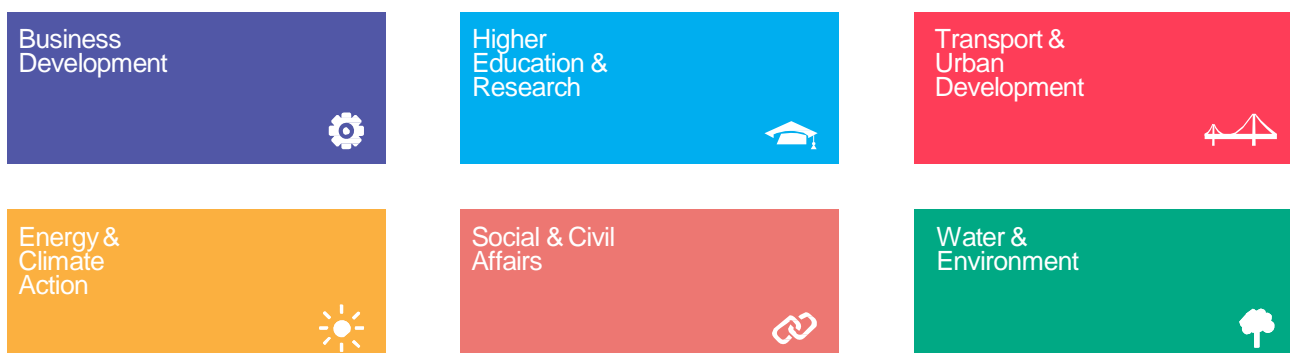

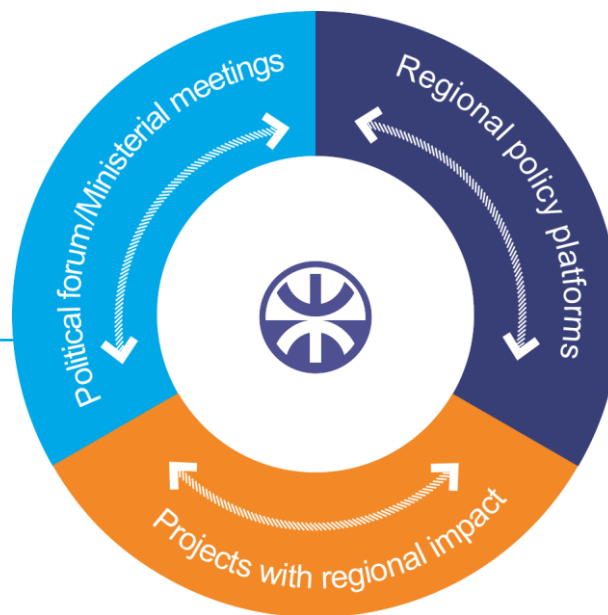
Building thematic common agendas

Declarations adopted by consensus by the 43 Ministers define the scope and objectives of a common regional agenda by sectors.

10+ Ministerial meetings have taken place since 2012 on key areas: Strengthening the role of Women in society • Transport • Energy • Industrial Cooperation • Environment and Climate Change • Digital Economy • Blue Economy • Regional Cooperation • Employment.

Fostering regional dialogue

Ministerial Declarations allow the UfM Secretariat to structure accordingly platforms for regional dialogue and cooperation. These regional platforms have involved a cooperative network of over **20,000** stakeholders including governments and members of parliament, international organisations, financial institutions, the private sector, civil society, universities and international experts through more than **200** Expert fora since 2012.



Translating the policy dimension into concrete projects

The added value of the UfM lies in the interrelation created between the policy dimension and its operational translation into concrete projects on the ground. The UfM Secretariat is currently promoting the implementation of more than **45** regional cooperation projects valued at over **€5** billion.

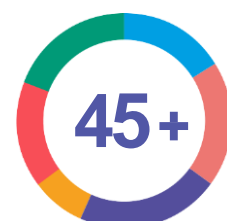

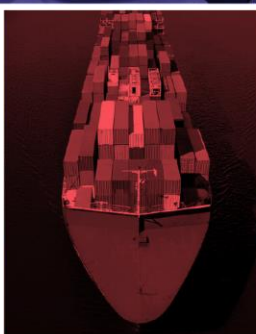
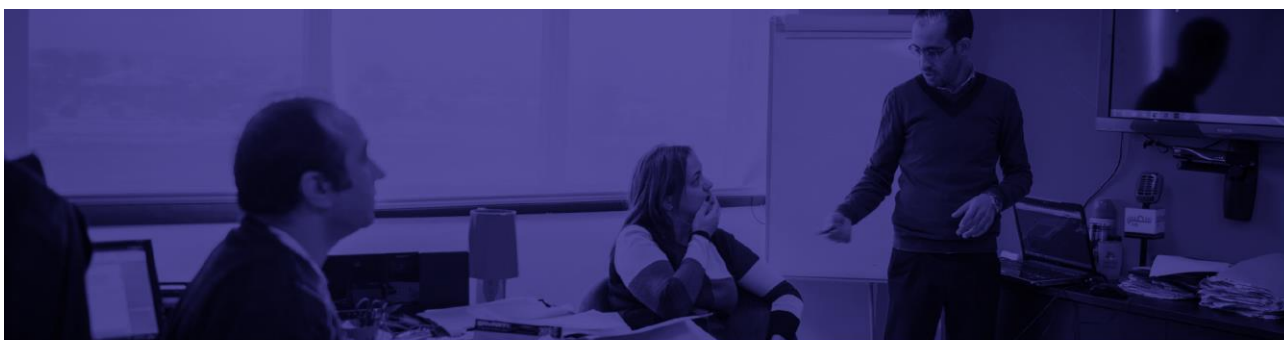

OBJECTIVES

Med4Jobs is a cross-sector initiative driven by the need for an integrated regional initiative in the area of job creation. It has been developed by the UfM Secretariat to help increase the employability of youth and women, close the gap between labour demand and supply, and foster a culture of entrepreneurship and private sector development. It covers both the supply and demand sides of the labour market, with an approach built on three pillars of action:

- ✿ **Employability:** enhancing the employability of priority sections of society – women, young people – by identifying and up-scaling successful training experiences across the region, which address the mismatch between skills and labour market needs.
- ✿ **Job intermediation:** improving information flows between job seekers and employers by replicating successful job facilitation and intermediation experiences.
- ✿ **Business-enabling infrastructure:** providing coaching to start-ups and SMEs through the development of business enabling infrastructures (incubators, coaching programmes, etc.).

Med4Jobs also serves as a regional platform for dialogue on employment, sharing of best practices, stakeholder interaction and collaboration.

- ✿ Positive impact on the employment rate among young people and women

OBJECTIVES

- ✱ The main objective is to strengthen the integration of Imbaba, one of the most populated and unplanned urban areas of Egypt in the city of Cairo
- ✱ This urban redevelopment project will provide new basic public facilities, job and revenue-creating activities as well as public spaces. Two public service centres will thus be created in Kawmeya and neighbouring zones will be developed through restoration of buildings, improved roads and upgrading of essential services (water, energy, sanitation, etc.). The project is also exploring the feasibility of a development plan for the urban zone to the west of the ring road, which has been strongly impacted by the expansion of irregular settlements.
- ✱ The Imbaba project is the first flagship project to be carried out within the scope of the Urban Projects Finance Initiative (UPFI). The Initiative is aimed at promoting and developing sustainable and innovative urban projects in the Euro-Mediterranean region that serve as best practice examples and are potentially replicable.

EXPECTED RESULTS

- ✱ The project is a model of sustainable urban redevelopment of a precarious neighbourhood in Cairo, which is also the most densely inhabited in Egypt.
- ✱ Redevelopment of 70 hectares of the district.
- ✱ 1 million inhabitants benefitting from the project.

- ☼ The project, promoted by UNIDO, is seeking to enhance women's economic inclusion and create favourable conditions for sustainable and inclusive growth by harnessing the great potential of women entrepreneurs in the targeted countries.

- ☼ The project will offer technical assistance to the women entrepreneurs to create and grow their businesses, through national business women associations. It will facilitate and accompany an inclusive policy dialogue between the key stakeholders to produce a set of recommendations and actions endorsed by all parties to promote an enabling environment for women's entrepreneurship in the region. It will also promote women-led investments through training, coaching, identification and facilitation of business partnership opportunities and access to finance.

OBJECTIVES

The Euro-Mediterranean University of Fes stands as a new regional centre of excellence contributing to regional stability and integration through the promotion of dialogue, intercultural exchange, sharing of knowledge and cooperation in the fields of higher education, research and innovation. Its particular regional approach is reflected in the diversity of nationalities of the students and staff as well as in the contents of study programmes, which focus on important topics for the integrated development of the Mediterranean region.

Framed within the UfM cross-sectorial **Mediterranean Initiative for Jobs (Med4Jobs)**, it aims at building a new generation of young people with a unique Euro-Mediterranean profile, who can actively play a role towards transforming the region from their future positions in an effective and cooperative way between both shores of the Mediterranean.

RESULTS

- 7,000 students from across the Euro-Mediterranean region and Sub-Saharan Africa enrolled in 2024.
- 650 highly qualified professors, researchers, administrative and technical personnel employed.
- 80% of students participate in mobility experiences abroad.
- 20% of students granted with full or partial scholarships.
- 26ha eco-friendly and world-class campus constructed.
- MAD 70,000 (approx. EUR 6,250): annual tuition fees.

OBJECTIVES

Through an integrated approach tackling all main sources of pollution, the project aims to rehabilitate the environment and water quality of Lake Bizerte through depollution efforts and improving aquatic life as well as living conditions for the surrounding populations.

The project will help to eliminate the main sources of pollution contaminating the lake and affecting the bordering communities to guarantee a healthy environment and allow for a better quality of life and for the development of sustainable urban and economic activities, such as agriculture, industry, tourism, aquaculture and fisheries.

RESULTS

- ⌘ Improved sanitary and environmental conditions for an estimated 400,000 inhabitants living close to the sources of pollution (531,000 in the entire Governorate)
- ⌘ Improved conditions for sustainable industrial production for three large state-owned and more than 20 public and private companies
- ⌘ Access to sanitation for 10,000 people in urban areas and 26,000 in rural areas
- ⌘ Development of activities and local employment opportunities in the fields of sewage, waste management, fisheries and agriculture
- ⌘ Strengthened know-how of actors as well as potential for initiatives from local NGOs
