Prequalification Notice No. 01/2014

At 10h00 on March 5th 2014 will be carried the opening of applications related to the “*Architectural Competition for the Design and Execution Monitoring of the Future Campus of the Euro-Mediterranean University of Fez*”. This will take place at the University’s Rabat Annex located at: Avenue Annakhil, Building 3, Apartment 4, Sector 6 (block 32), Hay Riad (CP 10110), Rabat.

The prequalification documents can be withdrawn at the Rabat Annex of the *Euro-Mediterranean University of Fez* or sent by post or electronic means to competitors requesting it at construction@ueuromed.org.

The content and presentation of competitors’ records must be provided as follows:

Candidates can either:

- Deposit their folds against receipt at the Registry of the University’s Rabat Annex (address above).
- Or send their folds through registered mail with acknowledgement receipt to the above office;
- Submit their folds to the Chairman of the Commission at the beginning of the Admission Committee meeting and before the folds’ opening.

Supporting documents to provide, in addition to the application, are as follows:

- a. Declaration on honor;
- b. Documents testifying the powers attributed to the person acting on behalf of the competitor. No voucher is required for an individual acting on his own behalf;

- c.** Certificate (or certified copy) less than one year old and issued by the competent authority of the place of taxation testifying that the competitor is in regular tax situation;
- d.** Certificate (or certified copy) less than one year old and issued by the *Caisse Nationale de Sécurité Sociale* in Morocco or its abroad equivalent, testifying that the competitor is in regular situation with this institution;
- e.** The certificate of registration in the Commercial Register for persons subject to the registration requirement in accordance with the legislation in force;
- f.** Certified copy of the authorization to practice the profession of Architect;
- g.** A legalized copy of the agreement stating the establishment of the group including the subject of the agreement, the nature of the group, the agent, the distribution of benefits, if any, and the duration of the agreement;
- h.** Architects or groups of architects must justify a support through multiple skills specified in the admission rules;
- i.** The architect, or at least one member of the group, must have achieved during the last 10 years or currently under construction, at least one project of university campus or a university with a scientific and technical vocation or a higher education institution with a scientific, technical and technological vocation or a similar project, worth at least 100 million Moroccan dirhams. These references must be supported by certificates (or certified copies of the original) issued by the public or private contracting authority or men of the art under whose direction the competitor performed those services. Each reference specifies in particular the nature of services, the amount and the year of realization and the name, status and appreciation of the signatory.

N.B:

- (1) Foreign architects (not registered with the national association of Moroccan architects) must be associated with a Moroccan architect cabinet;
- (2) Competitors not based in Morocco must provide the equivalent of the administrative documents above, and failing that, a statement before a judicial or administrative authority, a notary or a qualified professional body where such documents are not issued by their country of origin or provenance;
- (3) Incomplete applications will not be considered for the contest.
