# Women's Socio-Economic **Empowerment:** Projects for Progress

Barcelona · March 26-27, 2014



## **BACKGROUND**

Ministers in charge of gender issues from the Union for the Mediterranean Member States adopted at the Third Ministerial Conference on Strengthening the Role of Women in Society, held on 11-12 September 2013 in Paris, conclusions related to the economic, social and political rights of the women of the Euro-Mediterranean in the following three areas:

- Equal rights of women and men to participate in the political, economic, civil and social life:
- Fight against all forms of violence and discrimination against women and girls;
- Change in attitude and behaviour to attain gender equality with a view to promote women empowerment not only in rights but also in reality.

The Ministers have asked the Secretariat of the Union for the Mediterranean to identify and facilitate the development, launch and funding of projects, and to organize a project-oriented international conference "Women Socio-Economic Empowerment: Projects for Progress". This international Conference takes place in Barcelona on 26-27 March 2014.

## **OBJECTIVES**

The major goal of the Conference is to create a strong momentum for the women socio-economic empowerment in the region, by interlinking policy decisions as provided by the Ministerial declaration, mainstreamed development programs and projects on the ground. The Conference will aim at establishing a lasting cooperation platform as an effective contribution of the Union for the Mediterranean to the region's women empowerment agenda and to the mainstreaming of gender issues in the development of inclusive and sustainable economies.

More specifically, this Conference will aim at:

- 1. Developing stronger synergies and coherence among women-related initiatives and advancing the women socio-economic empowerment agenda, all in the light of common regional priorities;
- 2. Fostering projects, initiatives and programs with a regional dimension and eliminating possible bottlenecks;
- 3. Identifying sources of funding for the labeled projects, initiatives and programs.

## **EXPECTED RESULTS**

The main expected results of the conference are as follow:

- From an institutional and policy stand point:
  - Establish strengthening the role of women at the heart of all progress and development in the Mediterranean
  - Enhance (Reinforce) the political and technical dialogue on the best practices for promoting gender equality in the Mediterranean
  - ❖ Foster the formation of partnerships and the creation of networks between the various actors of the North and the South: government, civil society, multilateral organisations, and the private sector.
- From an project-related stand point:
  - Create enhanced synergies and reinforce coherence between initiatives
  - Identify new structural programmes and regional projects to be carried out
- From a financial point of view:
  - Better identify the sources of funding
  - Bring the donors and project promoters closer in order to establish partnerships

## **PARTICIPANTS**

The two-day conference will gather representatives of major public and private stakeholders involved in women socio-economic empowerment issues and project promoters interested and capable of delivering concrete projects on the ground for the benefit of the region's girls and women.

## AGENDA AND ORGANISATION

Each session would be conceived in a multistakeholder perspective, including public authorities, bilateral and multilateral agencies and institutions from the region and beyond, the private sector and representatives of civil society and the non-governmental sector.

The first day will include a series of strategy, policy and resource-oriented discussions while keeping a strong focus on operational aspects.

- The first session will focus on identifying major needs and potentials, obstacles to be overcome and opportunities to be seized.
- The second session would highlight priorities, strategies and ways of advancing socio-economic empowerment agenda via projects, initiatives and programs. It will be divided in two sessions, the first one will focus on public programmes and policies, and the second one will focus on the private sector programmes.

The second day will be divided in workshops which will give prominence to project promoters who will explore potential for synergy and coordination between different initiatives as well as the need for new and larger initiatives to be taken. The following subjects will be discussed:

- improving the value chain (handcraft, sustainable tourism and income generating activities)
- facilitating transition from education to work (vocational training, education, employment)
- improving women's access to decision-making positions (entrepreneurship, leadership and mentoring)

This conference will include the presentation of new projects and those entering a second phase of implementation. Funding cooperation agreements will be signed. The premises will also offer facilitation for B to B meetings.

Through this conference and the process which it will allow to launch, the Secretariat of the UfM will be fully exerting its role as a platform for the creation of regional partnerships and of networking for the different stakeholders of the Mediterranean, and for the promotion of efficient regional projects in the Mediterranean.

Value Creation has a transformative impact across sectors and economies. With regard to handicraft, as a main focus of this session and as a sector with traditionally much women involvement, there is often a need to adapt the design and quality of the products, to foster marketing and trade capacities, and to create distribution networks. Enhancement of the productivity in the value chain can bring not only more income for all the people concerned (in particular grass root women groups) but also greater benefits for the whole economy. C. IMPROVING WOMEN'S ACCESS TO DECISION-MAKING POSITIONS (Entrepreneurship, leadership and mentoring)

While education of girls has increased recently, women employability remains very low (an average of 23% in the Mena region). Women empowerment, as well as youth employability, could be significantly increased by reducing the existing skills mismatch between education/training and labour market demand. To achieve this goal, strong efforts must be made to foster concrete collaboration between universities, vocational training schools and employers (promotion of internships, study cases, career centers).
