

UfM Regional dialogue on women Empowerment

Lisbon, Portugal the 9th October 2018

Working languages: Arabic, English, French

Background

- In 2015, the UfM has launched the Regional Dialogue process on women empowerment, involving the UfM countries and the concerned stakeholders in the Euro-Mediterranean region with the objective to review with partner countries the progress made in implementing the 2013 Ministerial commitments and provide recommendations for the 4th ministerial meeting. Four priority areas were identified and four working groups were constituted one for each priority field:
 - · Raise women's participation in economic life, moderated by Italy and UNIDO.
 - · Improve women's access to leadership and decision making positions, moderated by France and OECD.
 - · Change stereotypes through education and culture, Moderated by Morocco and Anna Lindh Foundation.
 - · Combat violence against women and gender-based-violence, moderated by Egypt and UN Women.
- 4 working groups meetings were held in 2016-2017 respectively on 25-26 April 2016 in Barcelona, July 12, 2016 in Paris; July 19, 2016 in Amman, 20-21, 2016 September in Rabat, and 2 ad-hoc SOM: October 10, 2016 in Barcelona and July 4, 2017 in Madrid.
- A progress report¹ on the implementation of the third ministerial declaration has been produced on the basis of
 the individual country reports provided by UfM countries, Beijing+20 reports and supplementary literature
 produced by other key organisations operating in the region. 14 country reports were received from Algeria, Egypt,
 Finland, France, Germany, Italy, Jordan, Monaco, Morocco, Palestine, Portugal, Spain, Tunisia, and Turkey. The
 report has been endorsed by the Cairo Ministerial meeting.
- The 4th Ministerial Conference on strengthening the role of women in society was held on 27th of November 2017 in Cairo, Egypt and Ministers from the 43 UfM members adopted a strong ministerial Declaration² that has been drafted based on the regional dialogue and countries recommendations.
- The fourth UfM ministerial Declaration constitutes an ambitious road map toward achieving gender equality and women empowerment in the Euro-Mediterranean region. The 43 UfM countries have taken very strong commitments in the four identified priority areas and agreed to establish a follow-up mechanism baked-up with indicators to monitor progress, to evaluate the gender gap and to provide recommendations to policy makers and stakeholders, in order to improve the impact. They recommended that the mechanism should be implemented in complementarity and co-ordination with the existing gender-mechanisms in the region.

Meeting's objectives & outcomes

The meeting has two main objectives:

- 1. Agreed with countries the methodology that will be followed in monitoring the ministerial declaration:
 - Validate the origin/framework to be used as inspiration for indicators (SDGs indicators or identify different ones for the UfM Declaration).
 - As the Declaration is very ambitious, **decide for each priority areas** (violence, economic participation, leadership and stereotypes) **the urgent/priority issue** that will be monitored. **The UfM Secretariat, will propose**, <u>for validation by countries</u>, a set of indicators for the selected issues.
 - Validate the reporting mechanism as provided by the Ministerial Declaration. **The UfM Secretariat will propose**, <u>for validation by countries</u>, a report template. Do countries agree to use questionnaires?
 - **Data and statistics**: Which national sources of data and statistics that should be used? How to mobilise/work with the concerned institutions? What needs of capacity development at this regards?
- 2. Updating on regional and national initiatives, good practices and policies regarding three of the ministerial priorities: "Violence against women", "Women economic participation" and "Women in peace and security agenda" and exploring opportunities of synergies, collaborations and partnership.

The meeting format

The meeting will follow a roundtable discussion format where all participants are invited to react to speakers' presentations and to present their experience and provide their recommendations. Each panel will start with short presentations (between 7 to maximum 10 minutes) from speakers from different backgrounds and organisations who will give an overview of the discussed issue by presenting their experience, methodology of work and approaches, good practices and initiatives in the field of gender equality and women empowerment. The use PPT presentations is possible. Speakers need to provide us with their presentations before the beginning of the meeting.

Speakers presentations will be followed by a group discussion and recommendations/conclusions on the foreseen discussion points for each session.
