H.E. Nizar Baraka

Minister of Equipment and Water of the Kingdom of Morocco

Born on February 6, 1964 in Rabat, Nizar BARAKA, Secretary General of the Istiqlal Party since 2017, has been appointed, on October 7, 2021, by HIS MAJESTY THE KING MOHAMMED VI, Minister of

Equipment and Water.

Mr BARAKA holds a PhD in economic sciences from the University of Aix Marseille (1992) and a diploma in econometrics from the Mohammed V Faculty of Law (1985).

After a teaching experience at the Faculty of Legal, Economic and Social Sciences of Mohammed V University and at the National Institute of Statistics and Applied Economics, he joined the Ministry of Finance in 1996 where he held several positions of responsibility, before being appointed Deputy Director of the Directorate of Studies and Financial Forecasting in 2006.

Mr BARAKA was Minister of State for Economic and General Affairs (2007-2012), Minister of Economy and Finance (2012-2013), then Chairman of the Economic, Social and Environmental Council (2013-2018). He was awarded the "Best Finance Minister in the MENA Region for 2012" and "Finance Minister of the Year 2012" by The Banker, the Financial Times' reference press group. He was also awarded the title of "Finance Minister of the Year for the Middle East and North Africa, in 2013" by the magazine "Emerging markets", reference of the World Bank and the International Monetary Fund.

Mr. BARAKA is active in some national and international associations and organisations. He was appointed by HIS MAJESTY THE KING, in January 2005, member of the Averroes Committee for the rapprochement between the Moroccan and Spanish peoples, and contributed to the 50th Anniversary Report on Human Development.

Since 2006, he is a member of the National Observatory of Human Development.



Cristina Lobillo Borrero

Director – Head of Energy Platform Task Force in DG ENER, European Commission

Originally, from Cordoba in Spain, Cristina Lobillo Borrero is a lawyer with qualifications from Spain, Belgium and the Harvard Business School. Having previously worked in the Spanish government for the Ministry of Agriculture, Fisheries and Food, she

joined the European Commission in 2004, working originally on agriculture policy and then moving to trade issues. From 2014 to 2019 she was the Head of Cabinet to the then EU Commissioner for Climate Action and Energy, Miguel Arias Cañete. As Commissioner Miguel Arias Cañete was the EU's chief negotiator in the COP, she was present in Paris for parts of the COP21 session and therefore had an important role in the EU team. Former Commissioner's term in office was also noted for its successful overhaul of EU energy legislation under the so-called Clean energy for all Europeans package. From December 2019 to June 2020, she was Principal Adviser at the Directorate General for Agriculture and, from June 2020 to June 2022, she was Director for Energy Policy: Strategy and Coordination in the European Commission's Directorate General for Energy. In this role, she was heavily involved in the preparations of the legislative proposals of "fit for 55" package. Her responsibilities as Director also included overseeing EU international relations on energy issues, coordination with Member States as well as with the EU institutions, together with the communication, legal and economic aspects of EU energy policy. Since June 2022 she is Director – Head of Energy Platform Task Force in DG ENER, European Commission.
