The [2022 High-Level Conference on Women for Mediterranean](#) organised by the Union for the Mediterranean will take place in the afternoon of the **26th October and throughout the 27th**, in a physical format in Madrid.

During the High-Level Conference, Ministers from the Union for the Mediterranean (UfM) Members States and the UfM-Co-presidencies (EU and Jordan) will be invited as well as representatives of national, regional and international stakeholders from public and private sectors including financial institutions and international donors. The recommendations gathered from the Civil Society organizations will be certainly taken on board during the discussions.

The Conference will be preceded, on the 26th of October 2022 by the [5th \(UfM\) Ministerial Conference on Strengthening the Role of Women in Society](#), which will gather Ministers of the 42 Member States of the UfM responsible for women affairs and gender equality.

The Conference will provide an opportunity for a further exchange of experiences, good practices and lessons learned on women empowerment and women's rights in a regional-crisis (health, water, food and energy security) context.

These discussions will also contribute to shape **the Roadmap for the implementation of the Ministerial Declaration** and the regional agenda for the years to come, particularly towards an effective and inclusive gender equality policy, based on a gender transformative approach and the mobilisation of public and private actors in the region.

The experts' contribution to the discussions, taking place across the two days will be important in stepping up cooperation, focusing on **implementation, concrete delivery, and monitoring of impact**, while enhancing the visibility of past, on-going and future initiatives.

9:00-11:50 I. Women Economic Empowerment in the Regional Crisis context

In 2022, amid multi-layered and compounding crises including the ongoing pandemic, the climate emergency and large-scale conflict and displacement, the progress towards gender parity is stalling.

Not only are millions of women and girls losing out on access and opportunity at present, this halt in progress towards parity is a catastrophe for the future of our economies, societies and communities. Accelerating parity must be a core part of the public and private agenda.

As stressed by the [2022 Gender Equality report of the UfM](#), women are active drivers for economic and human growth, and key agents of change also in COVID-19 and other crisis economic recovery scenarios. However, women's access and participation in the labour market, and their engagement as entrepreneurs in the Mediterranean region remain significantly low.

The economic and social consequences of the pandemic and geopolitical conflict have paused progress and worsened outcomes for women and girls around the world. Conversely, the increasing representation of women in leadership in a number of industries, engagement in tertiary education overall and rebound in professional and technical roles are encouraging and may provide a basis for future efforts.

Collective, coordinated and comprehensive action will be needed to create sustained improvements and halt the risks of reversals. As a basis for action, close and constant monitoring of the gender gap is a critical first step.

In order to identify concrete actions to be implemented and the enabling conditions for their success at regional level, the invited speakers will tackle the challenges of an effective women's economic empowerment from three main perspectives.

12:15 – 14:00 II. Gender-just response to the climate crisis



The last UN Commission on the Status of Women (CSW66) recognized the disproportionate impacts of climate change, environmental degradation and disasters on all women and girls that can include loss of homes and livelihoods, water scarcity, destruction and damage to schools and health facilities and stressed the urgency of eliminating persistent historical and structural inequalities, discriminatory laws and policies, negative social norms and gender stereotypes that perpetuate multiple and intersecting forms of discrimination.

Gender-equality and the empowerment of women and girls remain essential for a sustainable natural resource's management, for mitigating and adapting to climate change, for protecting ecosystems, for building resilient futures for indigenous and rural women, and for conserving biodiversity. The participation of women in discussions and decisions on climate change mitigation and adaptation is essential to find sustainable and effective solutions.

In order to adequately address climate change, environmental and disaster and risk reduction, the policy actions should 1) promote women's and girls' full and equal participation and leadership to make natural resource management and climate, environment and disaster risk action more effective. 2) expand gender-responsive finance at scale for climate and environment action and to reach women's organizations, enterprises, and cooperatives; 3) building women's resilience in the context of agricultural and food systems, forest and fisheries management and the sustainable energy transition. 4) ensure equal access and rights to land, water, technology, technical advice and information for a greater food security, renewable energy; 5) enhancing gender statistics and sex-disaggregated data in the gender-environment nexus; and fostering gender-responsive just transitions.

15:00 – 16:30 III. Violence Against Women and Girls

Violence against women and girls (VAWG) is a complex phenomenon.

Gender-based violence is taking different forms and being highly sensible to conjunctural events. VAWG increased in the context of the Covid-19 crisis as well as in the context of political and armed conflicts.

One in three women worldwide experience physical or sexual violence, mostly by an intimate partner. Violence negatively affects women's general well-being and prevents women from fully participating in society. It has tremendous costs, from greater strains on health care to legal expenses and losses in productivity.

At least 155 countries have passed laws on domestic violence, and 140 have legislation on sexual harassment in the workplace (World Bank 2020). But challenges remain in enforcing these laws, limiting women and girls' access to safety and justice. Not enough is done to prevent violence, and when it does occur, it often goes unpunished.

It is essential to boost reporting tools and systems for victims of violence in these specific contexts, with particular attention to migrant women and vulnerable groups. VAGW is a phenomenon which shall be prevented by means of public awareness campaigns, trainings and cooperation between the public institutions and the civil society.



The need to bridge funding gaps, to ensure essential services for survivors of violence during the COVID-19 crisis, to focus on prevention, and to boost collection of data that can improve life-saving services for women and girls will be among the topics of the Third Panel.

16:30 – 17:30 IV. Media and Gender Equality

The media industry (newspapers, television, radio and social media) plays a key role in shaping values and opinions, including those related to gender. Media are one of the main sources of information that enable citizens to be better informed and make decisions about issues affecting their life.



However, the perpetration of gender stereotypes and the under and misrepresentation of women in media contents have been consistently demonstrated by research studies; the Global Media Monitoring Project, published in 2020, shows that women represent just 24% of news' subjects and sources. It also shows that only less than 1% of the stories analysed challenge gender stereotypes or mention gender inequalities.¹

Despite such research conclusions, media still struggle to adopt a global strategy able to ensure a nonstereotyped and non-discriminatory representation by adopting gender-sensitive lenses.

In addition to this, relevant stakeholders from civil society work hard to be effective in their advocacy mission, with particular reference to the difficulties related to the dissemination of information and contents via mainstream channels of communication.

We know that the media's sphere of influence is wide enough to become one of the most powerful tools to promote positive changes in the way genders are represented and, consequently, how they are perceived by society. By the way, the changes needed to favour a gender-sensitive approach require a combination of mechanisms and strategies bridging players from the media system and civil society.

This panel intends to investigate how media write and speak about global issues such as economy, climate crisis and violence against women with a gender perspective.

To this purpose, representatives from the media sector and civil society will share perspectives and strategies, starting also from existing good practices.
