Closing gender gaps in the MENA financial sector: towards womenled business development

# AGENDA



























The MENA region has the world's highest entrepreneurial inequality between men and women, where less than 5% of businesses are women-led, compared to a global average of 23-26%. Women in the MENA region endure some of the highest levels of discrimination in accessing production and financial resources, according to the United Nations Industrial Development Organization (UNIDO).

Every year, the MENA region suffers losses of \$575 billion due to the lack of female economic participation. For instance, the region's female unemployment rate is equal to 15.5 percent, compared to 6.7 percent for men, and is more than three times the global average. The gap in ownership of established businesses between men and women in the MENA region is more than 40 percent, the largest worldwide. The overall **Gender Gap 2022** in the **MENA region is at 62.6% which, of all regions, represents the largest gap to close.** According to the World Economic Forum Global Gender Gap Report 2022, it is indeed estimated that a timeframe of 152 years will be needed to close the gender gap.

In comparison with the previous year, within the region there is **0.9** percentage point decline in parity. Of the four-index considered in the above-mentioned report, the MENA region sees more equality in Health and Survival (96.4%) and Educational Attainment (95.9%), whereas there is little equality in Economic Participation and Opportunity (44%) and Political Empowerment (14%).

Integrating more women into the region's business landscape could help solve many of the region's economic problems, such as creating jobs and economic wealth, and tackling existing inequalities.

The Union of Arab Banks in partnership with the Union of the Mediterranean, and in collaboration with prominent international organizations is organizing a conference on "Closing gender gaps in MENA financial sector towards women-led business development" on March 6 and 7, 2024 in Cairo, Egypt.

This event will mark the **International Women's Day 2024** and will bring together senior bankers and entrepreneurs from the MENA region to shed light on the challenges faced by women entrepreneurs in scaling up their businesses, ranging from gender disparity in funding to lack of support. It will highlight the ongoing work on narrowing the gender gap in MENA financial sector towards women-led business development and will give the opportunity to exchange on promising practices and critical issues related to supporting women entrepreneurs in launching and expanding their businesses.
