5th Annual Conference on Water Finance and Investment

Making finance work for WASH services Imperial Ballroom, Triumph Luxury Hotel, Cairo (Egypt) 14th –15th October 2024

BACKGROUND

Achieving the water-related Sustainable Development Goals ("water security" in short) is a common goal and challenge of the countries around the Mediterranean as well as in the rest of the European Union and Africa. Achieving water security requires a financially sustainable water sector. In the Mediterranean region, the UfM Ministerial Declaration on Water approved in Malta in 2017 mandated the development of a Water Agenda and a Financial Strategy for Water, which were elaborated and endorsed in 2018. In order to help countries achieve the objectives of the Financial Strategy for Water, the UfM decided to launch an annual series of conferences focused on water finance and investment.

The first Annual Conference on Water Finance and Investments was organized in Rome (Italy) in December 2019, with a focus on public-private partnerships and the financial sustainability of the water sector. Following a pause in 2020 due to Covid-19, the series re-launched in 2021 in partnership with the EU Delegation in Egypt. Since then the conferences have taken place in Cairo (Egypt) in the framework of Cairo Water Week. The second conference focused on strengthening water investment policies. The third conference took place in 2022 and focused on water, climate and finance. The African Development Bank joined the partnership in 2023, when the fourth conference focused on water finance and the water-energy-food-ecosystem (WEFE) nexus. In June 2024, the UfM Regional Platform on Water supported a focus on WASH finance for the fifth edition of the conference.

This year Cairo Water Week will be organized in parallel with Africa Water Week. On this occasion, the annual conference on water finance and investment intends to provide a contribution to both events.

OBJECTIVES

The overall objective of the annual conferences is to support progress towards achieving water security in the Mediterranean and Africa by providing a high-visibility platform for policymakers and stakeholders to discuss how to further improve water finance and investment policies.

The specific objectives of the 2024 Conference are:

- 1. To seek high-level guidance for adopting a strategic approach to WASH finance and investment.
- 2. To identify the opportunities for investing in WASH while providing the largest impact.
- 3. To explore the scope for generating more internal resources in the WASH sector while ensuring affordability of WASH services.

- 4. To identify the benefits and challenges of developing WASH finance strategies, and the role of public finance.
- 5. To discuss how enhance engagement of the private sector in WASH finance and investment.

TARGET AUDIENCE

The 5th Annual Conference on Water Finance and Investment is targeted towards high level officials from Mediterranean and African countries in charge of water-related investment and finance policies, as well as representatives from national, regional and international stakeholders including: public agencies responsible for WASH-related investments; regulators of water supply and sanitation services; public and private providers of water and sanitation services; domestic and international financiers; water users; research centres; international agencies with an interest in water supply and sanitation issues; and other development partners.

The number of participants will be limited to a maximum of 100 participants on-site and a maximum of 120 participants on-line.

CONFERENCE OUTCOME

As in previous years, the UfM Secretariat, in consultation with the co-organizers, will prepare and publish a Policy Brief reflecting the conclusions and recommendations of the conference.

The conclusions and recommendations from the conference will contribute to the development of the UfM Recommendations on Water Finance that will be submitted for endorsement at the next UfM Ministerial Meeting on Water

DATE AND PLACE

The Conference will take place at the Triumph Luxury Hotel in Cairo (Egypt) on Monday 14th and Tuesday 15st of October under a hybrid format. The exact meeting room and on-line platform details will be communicated to registered participants in due course.
